- No reading or mapping program required from you. Just pick it up from the sFTP server on a timed basis.

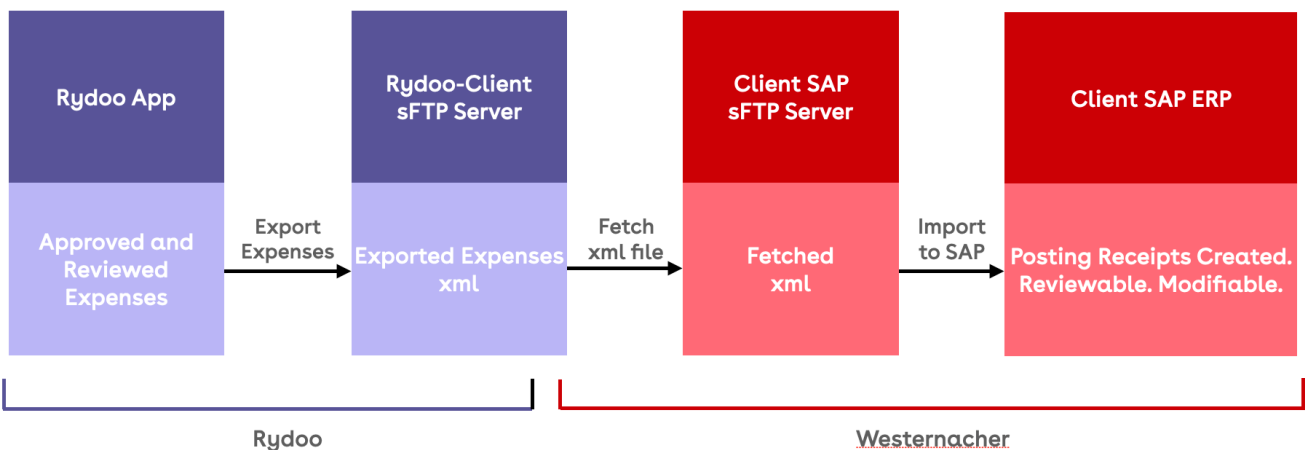
What are they offering?

Westernacher deliver the source code, technology and integration of expense data from Rydoo to SAP, implements it into the customer's system and takes care of the maintenance.

Solution Functionality



Handover to SAP: Fetches Rydoo expense export xml file from the joint Rydoo-Client sFTP server at a predefined time each day and transfers it to the client's own sFTP server.

Posting of Receipts: In SAP ERP, the files transferred from Rydoo are transformed into posting receipts and the original xml files are archived on the SAP server for future retrieval if required.

Optional Review and Modification: In SAP ERP, an Accounting member can check the automatically created SAP document for completeness and accuracy. Manual changes can be made to correct discrepancies. These changes are tracked.

The process ensures:

- That the uploaded and digitised receipts in the Rydoo application match the accounting receipts in terms of appearance and content
- That these are available for the duration of the retention period and can be made legible at any time within a reasonable periods (Section 257 (3) German Commercial Code, Section 147 (2) German Tax Code),,
- And that they can be made available for data access in the event of an external tax audit (Section 147 (6) German Tax Code).



This is suitable for companies in any country. It is not limited to Germany.
